*Release of All Claims*

In consideration for being accepted by Lawton First Assembly of God, Lawton, OK for participation in all youth activities for 2018 (including all trips and any other activities sponsored by Lawton First Assembly), we (I), being 21 years of age or older, do for ourselves (myself) (and for and on behalf of child-participant if said child is not 21 years of age or older) do hereby release, forever discharge and agree to hold harmless Lawton First Assembly of God, its members, officers, directors, employees, agents, representatives, successors and assigns thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expense, of any nature whatsoever which may be incurred by the undersigned and the child-participant that occur while said child is participating in the above-described trip or activity. Furthermore, we (I) [and on behalf of our (my) child-participant if under the age of 21 years] hereby assume all risk of personal injury, sickness, death, damage and expense (including attorney fees) as a result of participation in recreation and work activities involved therein. Further, authorizations and permission is hereby given to said church to furnish any necessary transportation, food and lodging for this participant. The undersigned further hereby agree to hold harmless and indemnify said church, its directors, employees and agents, for any liability sustained by said church as the result of the negligent, willful or intentional acts of said participant, including expenses incurred attendant thereto. (If the participant has not attained the age of 21 years): We (I) are the parent(s) or legal guardian(s) of this participant, and hereby grant our (my) permission for him/her to participate fully in said trip, and hereby give our (my) permission to take said participant to a doctor or hospital and hereby authorize medical treatment, including but not in limitation or emergency surgery or medical treatment, and assume the responsibility of all medical bills, if any. Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs.
